The SSA Head is requested to enter into an agreement annexing the required documents which are essential for settlement of medical bills. Such an annexure has already been issued/circulated vide this office letter No.A/Admn-II/Medical Facility/Guidelines/2011-12/88 dated 14.03.2012.


Unless the agreement is signed by both the parties (BSNL and Hospital), the hospital will not be considered as empanelled. If the empanelled hospital is not able to furnish IT Exemption Certificate issued by the Income Tax Department, TDS may be deducted fro from the payable bill amount.

Aafter agreement is made, the empanelment of the hospitals may be conveyed to this office with copy to CAO (OP & Mktg) O/o CGMT MH Circle Mumbai and also uploaded on SSA's website.
