The Screening Test for TOA (G)/TOA (TG)/TOA (P)/TOA (T) for promotion to the cadre of Sr. TOA (G) had been held on 16.12.2018 in Maharashtra Telecom Circle as per BSNL Corporate Office, New Delhi circular no. 250-16/2004-Pers/Estt-III. dated 02.07.2018 and this office letters no. A/DE/ST/2018/STOA/18 dated 18.09.2018, No. A/DE/ST/2018/STOA/Vol-1/21 dated 11.10.2018. The result of the screening test is hereby declared and mentioned vide Annexure-1 attached herewith.

2. As per BSNL Corporate Office, New Delhi Circular No. 27-1/2003-TE-II. Dated 23.01.2006, the successful officials of the Screening Test along with the officials of walk-in-group (if any) will form eligibility list for promotion to the cadre of Sr. TOA (G). The eligibility list shall be prepared by adopting the principals laid down in DOT Letter No. 252-1/91-STN (Pt) dated 27.04.1994.

3. Before implementing this order, the Heads of SSA/units should ensure that no disciplining /vigilance case is pending against the officials. In case any disciplinary/vigilance case is pending against the officials, he/she should not be promoted and the matter should be reported to this office without delay.



To the extent of Sr. TOA (G) posts available, select panel may be drawn from the officials of eligibility list and these officials may be imparted four weeks induction training as prescribed vide BRBRAITT, Jaipur letter No. TD-12/9/73 dated 21.01.2001. Thereafter, the trained officials may be appointed against Sr. TOA (G) posts.

5. The names of candidates, Roll No. and their category, etc. have been shown as furnished by the SSA/units concerned. However if any mistake is noticed w.r.t. details of candidates, the same may be brought to the notice of this office by concerned SSA/Unit.

6. BSNL reserves the right to cancel the result of any candidate at any time which is declared passed inadvertently vide this letter when any mistake is detected/discovered or due to any change of notified vacancies.

7. It is requested to communicate the result to the qualified candidates and copy of the result may be displayed in the Notice Board.
